- (v) The group shall finalise its report within 15 working days of this meeting.




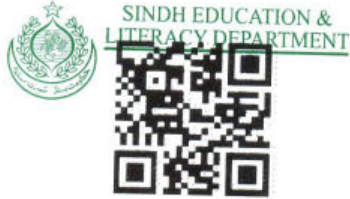
