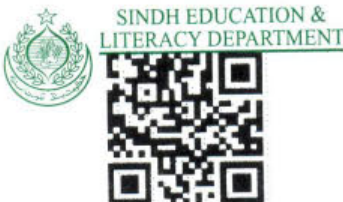

Terms of Reference

- The committee shall finalize district wise lists of all such cases / claimants whose ID has been blocked and salary stopped.
- The lists to be finalized from existing record of the department as well as by giving a "Public Notice" through various means of the media.
- The scrutiny committee shall convene first meeting / scrutiny of cases within 07 days of this notification and complete the exercise within next 30 days.
- The personal ID of only those employees will be unblocked and salary released with immediate effect (and not retrospectively), whose initial appointment is found genuine by the committee.

- (e) The committee shall record its minutes and each page of its recommendations shall be signed by all the members.
- (f) The committee shall submit a final report within two months and make recommendations to the department, AG Sindh and all other stakeholders to devise mechanism and setup effective controls to check the fake appointments and opening of forged IDs.
- (g) The committee may seek assistance of the respective Directors of School Education (DsSE), AG Sindh and any other stakeholder for achieving its objectives.

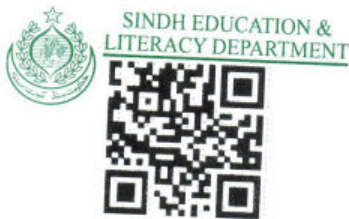
